Chief's Report

In 2019 the Sparta Police Department continued its commitment to excellence in policing. We looked for more ways to connect with our community and take proactive steps toward preventing crime, while dedicating services to aggressively investigate crimes that occurred. We increased our technological capabilities, saving us time and resources, and increasing safety for both the public and our officers. The Department pursued grants and other resources for responsible increases in manpower, equipment, and training opportunities.

The Sparta Police Department participated in several special events during 2019. We assisted during the visit of Vice President Pence at Fort McCoy – supporting the motorcade, traffic control, and security. We provided security for a number of community events, including Butterfest, various parades and races, and the Holiday Train. Department members took part in many community activities and groups, including Shop with a Hero, Christmas for Kids, Boys and Girls Club, National Night Out, and numerous school and community safety and informational presentations.

The Department integrated new technology, updating our records management system and investigative capabilities. The Sparta Police Department, Monroe County Sheriff's Department, 911 Communications Center, Monroe County Jail, and Cashton Police Department installed a joint records management system - Zuercher. The new system includes a mobile dispatch program and allows agencies to share records and information. The new system saves valuable time for patrol officers since much of the basic information entered in their reports is now done at the dispatch level, rather than requiring duplicate entry.


In 2019 we received a grant from the Wisconsin Department of Justice for Cellebrite equipment and training. Officer Lee and Detective Tovar are now trained Cellebrite operators and analysts. This technology allows us to extract and analyze information from cell phones during investigations. Previously, these cell phones were taken to an outside agency or the Crime Lab for such extractions. Having these capabilities of technology and training at our own department saves valuable time and resources during investigations.

As part of our goal to address community problems in new ways, this past year the Department established a Drug Interdiction Team. Our team received a grant for new equipment, which included a fume hood for drug testing. This makes our field-testing procedures much safer for officers, and increased the capabilities we previously had for testing. The team received specialized training with our District Attorney's Office and will continue to expand its training and objectives in 2020.

Department members worked hard to further train and integrate our Police Reserve Unit. The Police Reserve Unit is a volunteer group, consisting of civilian community members. They are trained by members of the Department to assist with special events, natural disasters, and certain types of service calls. In 2019 the Reserve Unit was utilized to assist with security at large events, traffic control, perimeter control of crime scenes, mental health transports where a second transport officer was needed, and various other assignments as needed. The Reserve Unit is a great way to involve community members in our department. It also allows us to expand department manpower without extending overtime costs.

In 2019 the Sparta Police Department saw an increase of almost 600 calls for service compared to 2018. This increase in call volume was managed while short-staffed throughout the year, often by several officers. During 2019 Officer Fischer and Officer Mrdjenovich both spent a portion of the year deployed overseas serving with the Army National Guard. Officer Welker left his patrol position for a Sheriff's Deputy position with Barron County, and his position was not filled until 2020. We also had several officers on light duty and medical leave for injuries, childbirth, etc. throughout the year. These open positions contributed to a large overtime expense for the Department and made it difficult for department members to utilize their time off during the year.

The Department looks forward to continuing to make positive changes in the coming year. We will continue our commitment to community policing and professional service. The Department hopes to increase our staffing level and continue to build our technological capabilities in order to provide the best service possible to the citizens of our City.





2019 Officer Training

The Sparta Police Department prides itself on providing a wide variety of training opportunities for its officers. We strive to grow professionally as a team by constantly seeking new chances to learn. While Department members attend training provided throughout the State, we also continue to partner with Western Technical College to sponsor training in Sparta. This provides an opportunity for more of our officers to attend a desired training at no/low cost, while bringing law enforcement personnel from across the State to our wonderful City. We also continue to certify our officers as instructors in various fields in order to provide in-house training for our entire staff at a much lower cost.

Sponsored Training

In 2019 the Sparta Police Department sponsored Operation RUSH – a national drug interdiction training. The training was held at WTC in October. Four officers from Sparta PD attended, and the training brought in officers from across the State of Wisconsin, as well as a few officers from other states.

We also partnered with Tomah Police Department to sponsor Kent Williams' *Breachpoint* seminar in October. Almost all officers from both departments attended, as well as officers from several surrounding agencies. Chief Williams' topics included the unique culture of law enforcement, the potentially negative consequences of performing well within the law enforcement culture, motivation, and balancing personal and professional lives.

2019 Officer Awards

Lifesaving Award—Officer Jenna Lee, Officer Corey Johnson, and Officer Chris Welker



On January 6, 2019, Officers Lee, Johnson, and Welker were dispatched to Perch Lake to the report of two juveniles that had fallen through the ice and were in the water. With the assistance from additional officers from the Monroe County Sheriff's Office and Wisconsin State Patrol, they were able to rescue one of the juveniles from the water by tying several ropes together and pulling him to safety. He was then transported by ambulance to Mayo in Sparta to be treated for hypothermia. Unfortunately, the second child was fully submerged prior to officers arrival and was later recovered by the Fort McCoy Dive Team. When the second child was located, he was transferred by Gundersen Air to Mayo Hospital in Rochester where he was later pronounced deceased. It is due to the selfless, heroic acts and the quick thinking of these officers that they were able to save one of the children.

Lifesaving Award—Sgt. Kyle Erickson and Officer Zach Fischer




In the early morning hours of November 23rd, 2019, Sergeant Erickson and Officer Fischer responded to the report of a house fire on Walrath St. Dispatch advised responding officers that the 9-1-1 caller reported occupants were trapped inside the home due to heavy smoke and were unable to escape. Upon arrival, Sgt Erickson observed dark smoke coming from the building and was unable to make entry through the front door. While attempting to find another way inside the residence, Sgt Erickson could hear someone inside the attached garage. He and Officer Fischer were able to force open a garage door and pull the woman to safety. Officer Fischer then found a ladder in the neighbor's yard and used it to climb to the second story of the residence. Officer Fischer broke a window and was able to pull a young girl outside. The actions and quick thinking of Sgt Erickson and Officer Fischer proved life—saving for a mother and her young daughter and are a true testament to their dedication to protect and serve the residents of the City of Sparta.


In the fall of 2019, the Sparta Police Department and Monroe County 911 Communications Center acquired new Records Management Systems. Attempting to draw numbers from two systems for the purpose of creating this report means that all numbers may not be exact.



2019 Use of Force Comparison Report

During 2019 the Sparta Police Department responded to almost 16,000 calls for service. Officers made over 2,000 arrests during those contacts. In their numerous daily contacts with the public, officers had to use force just 18 times during the year. Of those 18 times, the vast majority of incidents did not escalate past the officer using his/her hands for an escort or compliance hold of the suspect.

The Sparta Police Department requires its officers to complete a separate Use of Force Form for each instance wherein force is utilized. That form is reviewed by 3 supervisors for any inappropriate or untrained use of force. Should excessive or inappropriate force be identified, the incident is then forwarded to a Defensive and Arrest Tactics Instructor for review. Following that review, recommendations for training or discipline are forwarded to the Chief of Police.









Use of Force Statistics


2019 Suspect/Officer Injury Ratio





Arrest Percentage By Type of Crime










Five Year Traffic Crash Trend







Traffic Citation Percentage By Type of Offense





2019 Drug Report


For the purpose of this report, a "drug seizure" is an incident in which an illegal substance and/or drug paraphernalia as defined under WI Statutes Chapters 961 and 450 was seized, located, or recovered and taken into police custody. Data in this report has been compiled from SPD's records management system and evidence tracking program with information provided by the reporting officers. Illegal substances have been primarily tested and identified using presumptive field tests, although some have been confirmed from the Wisconsin Crime Lab.


Offender Demographics

In 2019, 178 individual offenders were cited, arrested, or were referred to court for drug-related offenses. Twenty subjects were repeat offenders and one offender had five different cases. Offenders' age ranged from 14 to 69-years-old with the average age of an offender being 31. The majority of offenders, 61%, were males.



When Drugs Were Seized







Methamphetamine and THC were included in this graph as they were the most and second-most commonly encountered drug.

How Officers Encountered Drugs




"Complaints" include calls originating from citizens, Probation/Parole agents, or another law enforcement agency.

How Drug Seizures Were Processed


In 2019, 77 drug-related municipal citations were issued, and 114 offenders were arrested while 22 offenders were referred to the District Attorney on drug charges. Drug citations were issued for possession of marijuana, possession of synthetic marijuana, and possession of drug paraphernalia.



Only 19% of offenders in possession of just marijuana were arrested; many of whom had prior drug convictions and/or also had additional criminal offenses attached to the case.

Methamphetamine

From 2016 to 2018, Sparta PD saw a nearly 27% increase in meth seizures. 2019 was slightly lower than the previous year, but officers still averaged more than one seizure per week.



A total of 61 different offenders were arrested or referred to the District Attorney for charges relating to meth possession.

School Resource Officer

Officer Kyle Seubert completed the 2018-2019 school year as the School Resource Officer. Prior to leaving the position, Officer Seubert had been the SRO for 13 years. In June of 2019, Officer Jenna Lee was assigned to the position beginning the 2019-2020 school year. Officer Lee is an eight year veteran of the Sparta Police Department and was excited about the ability to interact with the students and teachers of the Sparta School District and the rewards and challenges of policing in a school environment. Officer Lee was able to build strong relationships with students in a number of ways. She read to several classes, joined the students for lunch and recess, and helped them with many projects and events throughout the school year. She also did presentations to classes on internet safety, bicycle safety, and Halloween safety. In addition to working within the schools during the day, Officer Lee attended several sporting events and after school activities.







In 2019, officers responded to a total of 626 calls for service throughout the school district. This would include calls for service at the Sparta High School, SAILS High Point, Meadowview Middle School, Meadowview Intermediate School, Lakeview Elementary School, Lawrence-Lawson Elementary School, Maplewood Elementary School, Southside Elementary School and the Sparta Administrative Building.




Officers responded to numerous different types of calls during the school year. Out of the 626 calls for service, 156 citations were issued and 44 referrals were made to Human Services.





The most common citations issued at the schools were for underage tobacco violations, underage alcohol, truancy, and disorderly conduct.



A total of 44 referrals were made to Human Services. The most common referrals were for Criminal Damage to Property, Disorderly Conduct, and Battery.



2019 Day Shift Report

01-05-2020 Forced entry break in at known drug house on 700 block of W. Oak. Suspects left when the homeowner confronted them. Suspects identified and referred on charges.

01-06-2019 Officers responded to Fisherman's park for a report of children who fell through the ice. Officer were able to rescue one child from the lake but tragically 9 year old Jaden Stalsberg died from drowning.

01-10-2019 Officer responded to a violent domestic call on the 100 block of N. Court Street. The intoxicated male suspect attempted to flee by jumping out a second story window. He was severely injured in the fall and transported by ambulance to a hospital. Charges were referred on the suspect.

01-19-2019 Shoplifting incident at a downtown clothing store. Officer recognized female from surveillance video as she had previously stolen from Kwik Trip. Arrest made.

02-03-2019 Officers responded to a driving complaint and located the vehicle in the Family Dollar parking lot. Driver arrested for OWI and drug paraphernalia.

02-15-2019 Complaint of same female shoplifting from Wal-mart multiple times. Female stole several hundred in merchandise, mostly cosmetics and electronics. Suspect identified, arrest made.

02-22-2019 Theft complaint on North Street. Victim had several thousand dollars stolen from a secret location in her residence. Investigation revealed an acquaintance took the money. Suspect was arrested and referred on theft charges.

02-22-2019 Injury crash at the Hwy. 27/River Rd. roundabout.

02-22-2019 Injury crash at Hwy. 16 & Industrial.

03-30-2019 Report of a man huffing hazardous substances on Central Ave. Male suspect arrested and held of a probation hold.

04-03-2019 Female suspect picked up on a probation warrant. Additional charges filed after drugs were found on her.

04-03-2019 Female suspect referred on theft charges after she attempted to steal a cart full of merchandise at Wal-Mart. She fled but was identified by surveillance video.

04-05-2019 Two suspects arrested for stealing drug test kits from Wal-Mart. Both were held on probation holds.

04-05-2019 Officers responded to a report of an impaired cashier at a retail store. Female suspect arrested and methamphetamine found on her.

09-03-2019 Suspicious activity reported on N. Water Street by Woodlawn Cemetery. Suspects were found to be in possession of methamphetamine.





2019 Night Shift Report

The 2019 year brought a considerable amount of change and movement amongst the Sparta Police Department officers and their assigned shifts. The sergeants started the first half of the year out working an 8.5-hour shift rotation while patrol officers worked a 12-hour shift rotation. The night shift consisted of a 6 PM to 6 AM schedule. The sergeants switched to a 12-hour shift schedule aligned with the patrol officers beginning July 1st.

Day shift and night shift also had several overlapping power shifts throughout the year. These power shifts provided extra coverage during the times of day when the city experienced the highest call volumes.

A total of 12 different sergeants and officers worked night shift throughout the course of the year.

Night Shift Notable Cases

19-0035: On January 10, 2019 at about 6:05 AM, officers were dispatched to the 100 block of N. Court St. for a disturbance. While attempting contact at the residence, a male subject jumped out a second story window causing multiple injuries to himself. He was taken to the Sparta Hospital for a suspected broken hip, a severe laceration to his chin, and other potential injuries. The female resident was uncooperative and was found to have attempted to conceal a bottle of whisky in her pants. Both the male and female subjects were found to be out on bond. The male was referred to the Monroe County District Attorney's Office for Felony Bail Jumping and Disorderly Conduct, Domestic Abuse related. The female was arrested and booked into the Monroe County Jail for Bail Jumping.

19-0124: On February 2, 2019, at approximately 10:20 PM, an officer on patrol initiated a traffic stop for a suspected license violation. After the officer activated emergency lights, the officer noticed a small, white bag thrown from the front driver side window, which was later recovered by Sparta PD officers. The bag contained about a gram of methamphetamine. The operator, a 43-year-old La Crosse woman, was arrested for a warrant, Possession of Methamphetamine and Possession of Drug Paraphernalia. The passenger, a 26-year-old male from Lone Rock, WI, lied about his identity to officers and was also arrested for Possession of Methamphetamine and Possession of Drug Paraphernalia. During the booking process at the jail, his identity was confirmed and he was additionally arrested for Resisting/Obstructing an Officer.

19-0480: On May 9 2019, at about 11:06 PM, an officer observed a pickup fail to complete a stop and operating with defective brake lamps. The officer stopped the vehicle and the driver, a 27-year-old female from La Crosse, was found to have a Department of Corrections warrant and was arrested. A K-9 alerted to the odor of drugs on the suspect vehicle. A vehicle search was conducted and a small amount of a THC substance was found in an electronic smoking device. Two passengers were cited municipally and released. Once at the jail, the driver was found concealing about 15 grams of methamphetamine inside her person. She was arrested on methamphetamine charges as well.

19-0861: On August 2, 2019, at about 8:40 PM, an officer on patrol followed a vehicle that had been seen leaving a known drug residence. The officer conducted a traffic stop on a vehicle for a traffic offense. After making contact with driver, a 30-year-old La Crosse woman, officers learned she had a warrant for her arrest. As officers attempted to arrest her, she fled in her vehicle and led officers on a 3-miles vehicle pursuit. Officers terminated the pursuit due safety concerns. The vehicle was located abandoned a short time later. A search of the vehicle produced multiple drug-related items. The driver was located later and was arrested for numerous traffic and criminal offenses.

19-1114: On September 25, 2019, at approximately 8:40 PM, Officer Fischer observed a male and female leaving a well-known drug area together. Officer Fischer made contact with the subjects, identified as Theresa Hansen and Joshua Miller. Officer Fischer stepped out with Theresa and Joshua as they were walking. Theresa and Joshua gave conflicting stories of their whereabouts and current activities. Officer Fischer then conducted a consent search on Theresa and an ACT 79 Search on Joshua. Drugs and drug paraphernalia was located during the search. Theresa was arrested for Felony Bail Jumping and Possession of Drug Paraphernalia. Joshua was arrested for Possession of Methamphetamine, Possession of Marijuana, Possession of Drug Paraphernalia, and a Probation Hold.

- **19-1171:** On October 5, 2019, at approximately 8:25 PM, the Sparta Police Department was dispatched to a disturbance at El Vallarta Restaurant. Officers arrived on scene and determined that two employees had been involved in a physical altercation. Florentino Narvaez Torres and Alberto Espinosa started to argue in the kitchen at El Vallarta when Florentino pick up a knife. Florentino followed Alberto to the dining area of the restaurant and Alberto threw a chair at Florentino, knocking the knife out of his hand. Florentino and Alberto began to fight in the dining room, hitting each other several times until the fight was broken up by restaurant employees. Florentino and Alberto sustained substantial injuries and were hospitalized. Florentino was arrested for Endangering Safety with a Weapon, 2nd Degree Recklessly Endangering Safety, and Substantial Battery. Alberto was arrested for Substantial Battery.
- **19-1246:** On October 18, 2019, at approximately 10:34 PM, the Sparta Police Department responded to the House of Shadows, 501 Osborne Drive, for a report of an intoxicated male assaulting the House of Shadows volunteers. The suspect left prior to police arrival, but witnesses provided a detailed description of the suspect and vehicle. Another officer located the suspect vehicle and initiated a traffic stop. The suspect was identified as Irwin Dykes. Drugs and alcohol were located inside the vehicle. Further investigation determined that Dykes caused injury to a 14 year old and a 17 year old after punching them. Both juveniles were volunteers at the House of Shadows. Dykes, was believed to be under the influence at the time, was arrested for Child Abuse, Intentionally Causing Harm, Disorderly Conduct, and drug related offenses.
- **19-1283:** On October 25, 2019, at about 11:40 PM, officers were dispatched to a fight at the Harris Crossing Bar. When officers arrived, they encountered an unconscious male lying in the roadway with an obvious injury to his head. He was transported via helicopter to a La Crosse hospital. After investigation, it was learned that the injured subject had attacked another bar patron with a beer bottle before leaving the bar. The other party followed him out and engaged in a physical confrontation in the street, resulting in the injury. Both of the men were ultimately arrested and charged with felony offenses.
- **19-1479:** On November 23, 2019, at about 2:45 AM, officers responded to a reported physical disturbance between a male and female party on E. Montgomery St. When the first officer arrived, he encountered a 30-year-old Sparta man inside the residence who had armed himself with several knives and was demanding that the officers shoot him. The man ignored orders to drop the knives before he had to be subdued with the use of a TASER from a second officer, resulting in him being taken into custody without further incident. The suspect was medically evaluated and taken to jail for domestic-violence related- Recklessly Endangering Safety, Disorderly Conduct, and Criminal Damage to Property, as well as Resisting an Officer.
- **19-1480:** On November 23, 2019, at about 5:40 AM, officers responded to a house fire at 302 Walrath St, with the residents reportedly trapped inside the residence. Officers located an adult female inside the garage and were able to force the garage door open to remove her from the residence. An officer found a nearby ladder to gain access to a second story bedroom window where the juvenile female caller was rescued from the residence. While on scene, a Sparta Ambulance Service EMT suffered a medical emergency and officers and other ambulance personnel performed lifesaving measures on him. Ultimately, the EMT recovered and returned back to work several months later. Even though the home was a total loss, the City of Sparta recognized the juvenile caller for her brave efforts in providing the dispatcher with enough information so that she and her mother could be rescued. The two officers were also received life-saving awards as well.
- 19-1597: On December 22, 2019, at approximately 4:53 AM, Officer Johnson initiated a traffic stop on a vehicle on Montgomery St. Officer Johnson observed the vehicle parked at an apartment complex known for recent drug activity. He also noticed the vehicle's registration status was suspended. Officer Johnson made contact with the operator of the vehicle who was identified as Rhonnie Leszczynski. During the traffic stop, Rhonnie was found to be in violation of her bond imposed curfew. A search of Rhonnie's vehicle produced several drugs and paraphernalia. Rhonnie was arrested for Possession with Intent Methamphetamine, Possession of THC, Possession of Drug Paraphernalia, Possession of Prescription Pills without a Prescription and Misdemeanor Bail Jumping. Rhonnie was also issued citations for Operating after Suspension, Operate after Suspension of Registration,

and Operate Motor Vehicle without Insurance.

Citizen's Academy

We were again able to host a Citizen's Academy in 2019. The academy is our way of providing the participants with the opportunity to learn more about the duties and responsibilities of the employees of the Sparta Police Department. It also gave them a look at the day-to-day operations of the department. We also hope to foster a better working relationship between the department and the citizens that we serve.

This year we had twelve participants in the academy, each hoping to gain a better understanding of what we do as police officers. The academy sessions began in September and finished in mid-November. Most of the sessions took place on Tuesday nights from 7:00 pm until 9:00 pm. The schedule also includes three Saturday sessions. Tuesday night sessions included; tours of the Sparta Police Department, the Monroe County 9-1-1 Communications Center and the Monroe County Jail, a presentation about the court system by Monroe County Circuit Court Judge Todd Ziegler and Monroe County District Attorney Kevin Croninger, an emergency vehicle operations driving course, a presentation on evidence collection, a TASER presentation, and a K9 Demonstration. The Saturday sessions included; a day at the firearms range, shoot/don't shoot scenarios, and a mock traffic accident that was presented by Gundersen Air, Sparta Area Ambulance Service, and the Sparta Area Fire Protection District.

The academy ended with a family-friendly dinner at Jake's Northwoods where each participant was given a certificate of course completion and a Sparta Police Department challenge coin. We appreciate the opportunity to give interested area residents a look inside the Sparta Police Department.

The day concluded with a tour of the Gundersen Air Sparta Hangar and a close up look at the helicopter.











During the TASER demonstration session, Sgt Ames provided a brief presentation on the TASER and how it works. Each participant was able to voluntarily experience the sensation of neuromuscular incapacitation caused by the TASER and also shoot the TASER at a target.

This year the Bollig's, who run the pancake and sausage breakfast and cheese curd stand, presented our K9 Program with a donation check of \$750.


National Night Out
