Mayor Gust called the meeting to order at 6:00 p.m.

Roll Call was done by the City Clerk.

The Pledge of Allegiance was led by Alderman Humphrey.

A motion was made by Ed Lukasek and seconded by Josh Lydon to approve this agenda. Motion carried 6-0.

The Mayor presented a Service Award to Kyle Guralski for 15 years of service with the Police Department. Kyle was not able to make this meeting so Emilee Nottestad will take it to him.

A motion was made by Ed Lukasek and seconded by Matthew Hoffland to approve the consent agenda consisting of the minutes of the last regular meeting of May 12, 2021, and monthly bills. Motion carried 6-0.

Chief Emilee Nottestad presented her annual report on the Police Station. She went over some highlights of last year dealing with crime and drug issues during the pandemic. The department had to adjust their schedules and how they handled everyday work trying to social distance and handle the challenges of COVID. She would like to see an increase in staffing this year and the starting wages increased as it is hard to get applicants and keep them. Our wages are well below what other cities of our size are offering. The police officers all over the country are facing a decrease in public support. We are fortunate in our community to have a strong connection with the public. There were some retirees in 2020 as well as new hires and promotions in 2020.

ORDINANCE PERTAINING TO REMOVAL OF SCHOOL ZONE PARKING RESTRICTIONS ON EAST FRANKLIN STREET, NORTH BENTON STREET, AND SPRING STREET

THE COMMON COUNCIL OF THE CITY OF SPARTA, MONROE COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. Sec. 7-94(a) of the Code of City Ordinances is hereby amended so that the following paragraphs shall be removed:

- (1) The south side of East Franklin Street from the east line of North Spring Street to the west line of North Benton Street.
- (2) The west side of North Benton Street from the south line of East Franklin Street to the north line of the driveway of the school parking lot.
- (7) The West side of L for the first 150 feet North of Oak Street.

and the remaining paragraphs to be renumbered and to read as follows:

Sec. 7-94. - School zones.

(a) No person shall park a motor vehicle and no owner of a motor vehicle shall allow it to be parked for any period of time between the hours of 7:30 a.m. and 4:30 p.m. on school days on the following streets and public ways:

- (1) The east side of South L Street from the north line of West Oak Street to the south line of West Main Street.
- (2) The west side of South L Street, commencing at the south side of Jefferson Avenue, thence 250 feet south.
- (3) On the following streets and public ways, residential parking only from 7:30 a.m. to 4:30 p.m. school days only, to-wit:
 - a. North side of West Montgomery Street from North Black River Street to Drake Street.
 - B .South side of West Montgomery Street from Goodman Street to Drake Street.
 - c. Goodman Street, Russell Street, Williams Street and Eyler Street.
- (4) The east side of Spring Street for the first 360 feet south of Franklin Street.
- (5) On the following streets and public ways, residential parking only, for the first 130 feet south of Central Avenue on the east side of North L Street.

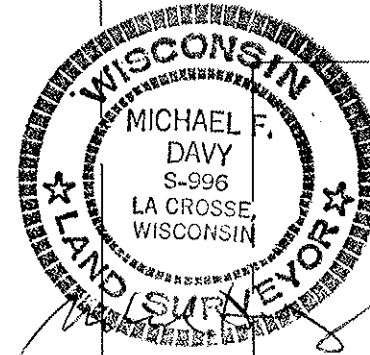
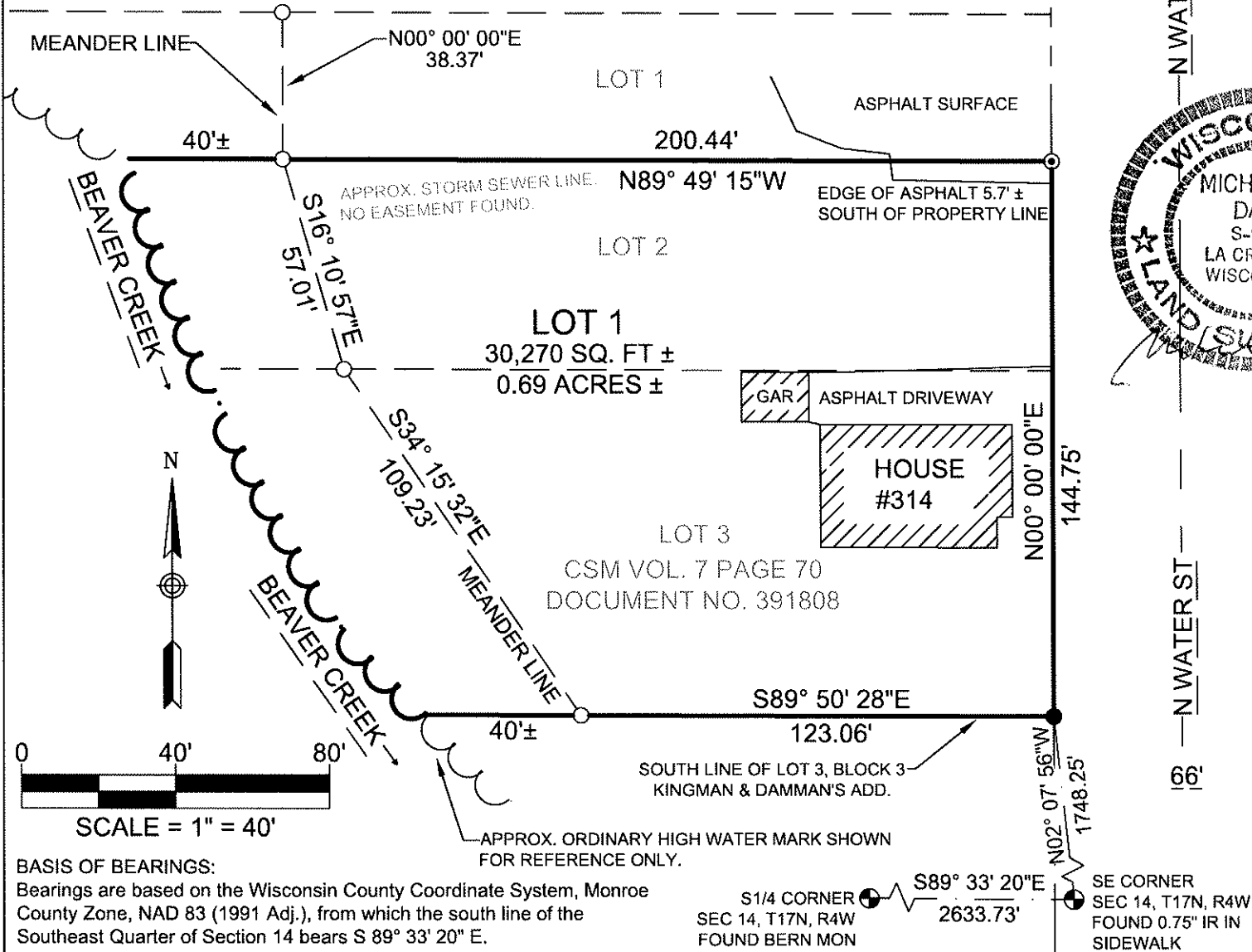

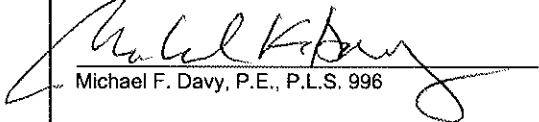
