It was asked about the status of LMI Properties court case. Dan Hellman stated the injunction was granted in Circuit Court, so no city fines can be assessed. Even though their business meets the Salvage Yard ordinance and would need an annual license, the city still may not impose any fines. He also stated he has had productive discussions with their attorney.

Mark Sund stated he was not sure of the exact status of Aldi's and their construction schedule, but he did feel they would be starting very soon.
