

The Annual Report of the City of Sparta Police Department, for the period of January 1st through December 31st, 2017, is herewith submitted for your review.

The staff worked very hard compiling the 2017 data, to make this report very informative and entertaining to read. The report contains a yearend review for the entire department.

As you review this repot you'll notice the following:

- Calls for service decreased by 1%
- Meth related drug arrests increased by 9%
- Crimes against Government increased by 9%
- Traffic citations increased by 4%
- Use of Force incidents decreased by 60%
- Crimes against children decreased 3%
- Juvenile citations decreased 5%
- Proactive Police services increased 3%

The future demands and challenges of local Police Departments are constantly changing and growing, as you can see in the news. The Sparta Police Department is always striving to be innovative and forward thinking. Partnering with other agencies and community organizations is very important to the Sparta Police Department's mission, so we can better serve the residents of the City of Sparta. We strongly believe that working in a partnership with government and civic leaders will create a positive influence on the Sparta Community.

# 2017 Officer Training

The 2017 training year continued Sparta Police Department's commitment to officer development. Officers focused on areas of specialties including tactical skills, leadership development, investigatory strategies, technology in law enforcement, legal updates, and current trends in crime and policing.

Aside from our State of Wisconsin-required training in Firearms Qualification, Emergency Vehicle Operations, and Defense and Arrest Tactics, officers were able to participate in a variety of other skills trainings on a regular basis. Our members of the Monroe County Combined Tactical Unit (Officer Nelson, Detective Kuen, Officer Johnson, Officer James, Officer Guralski and Officer Fischer) train monthly. Our K-9 officers (Officer Johnson and Officer James) train with a regional group of K-9 officers on a monthly basis, as well. Our sniper (Officer Guralski) trains monthly throughout much of the year. Our Department Honor Guard (Sergeant Erickson, Officer Welker, Officer Ludovice, Officer Fischer, Officer Nelson and Officer Grones) train on a quarterly basis.



Sparta Police Department had a few notable highlights in the 2017 training schedule:

In June the Department coordinated a large-scale active-shooter drill at the Gundersen Clinic in Sparta. This event was organized by Officer Nelson, who also serves as a Team Leader for the CTU Team as well as an EMT for Sparta Area Ambulance. The event included numerous Monroe County agencies including the Sparta Police Department, Monroe County 911 Communications Center, Sparta Area Ambulance, Monroe County Combined Tactical Unit, area media and Gundersen Lutheran. During the simulated active-shooter event, a hostile individual entered the clinic and shot several individuals including staff and patients. Officers responded and a hostage situation ensued. The Monroe County Combined Tactical Unit and Hostage

Negotiations Team assisted. Patients were triaged and evacuated. Eventually the shooter (played by Sergeant Joel Ames) was taken into custody and the hostage was recovered. It was a tremendous learning opportunity for everyone involved.











Also in June the Sparta Police Department hosted an ARIDE Training (Advanced Roadside Impaired Driving Enforcement) in Sparta. Officers from around the state participated in the training. ARIDE trains law enforcement officers to observe, identify and articulate the signs of impairment related to drugs, alcohol or a combination of both. By coordinating and hosting the training locally, our agency was able to send 5 of our officers who had not yet attended this training at no cost for the training or any travel expenses.



In July the Sparta Police Department once again worked with the Tomah Police Department to provide Advanced Patrol Tactics training. This training establishes a trained, coordinated response protocol throughout Monroe County. All Sparta and Tomah officers, as well as some of the smaller Monroe County agencies, are now trained.



In August we were excited to host the national Desert Snow Criminal Terrorist and Interdiction Training in Sparta. This training has not been offered in our area before, so we were eager to bring it to Sparta. Sparta hosted law enforcement officers from around the country for this event. The training focuses on drug interdiction, traffic stops, searches, evidence collection, interviews and


courtroom testimony. This is not a training that we would be able to send our officers to when offered in other areas of the country. However, by hosting the training, 3 of our officers were able to attend.



Sparta Police Department takes great pride in having a well-trained, highly-skilled group of officers. Our commitment to regular training, as well as the diversity of training we offer, means better service to our community and citizens. It also means better officer and community safety, and decreased liability. We are proud to protect and serve the City of Sparta and remain focused and committed to developing the best possible ways to do so.






# 2017 Five Year Trends








# Arrest Percentage By Type of Crime

# Municipal Offense By Type








2017 Suspect/Officer Injury Ratio




2017 Alcohol Usage Factor








# Traffic Citation Percentage By Type of Offense




# Traffic Stops Warnings vs Citations

# Five Year Traffic Crash Trend





# Drug Arrest and Citation Percentages By Type of Offense








### 2017 Drug Report

For the purpose of this report, a "drug seizure" is an incident in which an illegal substance or drug paraphernalia as defined under WI Statutes CH. 961 and Ch. 450 was seized, located, or recovered and taken into police custody. Data in this report has been compiled from SPD's records management system and evidence tracking program with information provided by the reporting officers. These statistics do not include data collected from Joint Special Investigations Unit.


#### Who We've Dealt With

In 2017, over 200 offenders were cited or arrested for drug-related offenses. Of that group, the youngest offender was 13, and the oldest was 59-years-old. The average age of an offender was 27. The majority of all drug offenders, 64%, were males.

The age of offender did vary to some extent on the drug of choice. The average age of an offender who was found in possession of meth/meth paraphernalia was 33, whereas the average age of an offender with only marijuana and related paraphernalia was 25.



### What We've Taken off the Streets




This graph shows the frequency in which officers seized a common specific drug and its related paraphernalia. Some cases included seizures of several different types of drugs.





## When Drugs Were Seized






### **How Officers Encountered Drugs**



This graph depicts how officers located illegal drugs. "Complaints" include calls originating from citizens, Probation/Parole agents, or another law enforcement agency. "Other officer-initiated activity" includes pedestrian checks, suspicious persons/vehicle checks, or other actions initiated by the officers excluding traffic enforcement.


In regards to traffic enforcement, SPD initiated SPD initiated 5598 traffic stops in 2017. Drugs and/or paraphernalia were located in <u>1 out of about every 53</u> of those contacts.

### **How Drug Seizures Were Processed**



A referral to the DA (District Attorney) is usually done if the offender(s) is not located or if the DA is to evaluate the case later. An HS referral (to Human Services) is typically used when the offender is a juvenile. Cases with "no action taken" include cases where drug items were found without someone actually in possession.

Officers can use discretion in issuing municipal citations for minor drug offenses, such as possession of marijuana, possession of synthetic marijuana, and possession of drug paraphernalia, instead of making an arrest.




A large majority (73%) of offenders with marijuana only were issued citations rather than being arrested for simple possession.

### Methamphetamine

Like many area communities, Sparta has seen an increase in meth use in recent years. The most common items officers have seen associated with this drug are plastic "gem" bags, syringes/needles, and glass smoking devices. Aside from marijuana, meth was the most commonly found drug by the Sparta Police.

A total of 65 total different offenders were arrested or referred to the District Attorney for charges relating to meth; 40 males, 25 females. The youngest offender was 18-years-old and the oldest was 58. The average of female offender was 32 and the average male offender was 34.



### **Other Drug Notes**

Officers seized 14 vials of Naloxone (Narcan), the drug used to counter an opiate overdose. The Department also received their own Naloxone kits and officers were trained in the emergency administration of the drug for responding to opiate overdoses.

The drug fentanyl was recovered on at least two different occasions. Some unidentified substances have been sent to the Wisconsin Crime Laboratory for testing and several results are still pending as of this report.

#### 2017 Citizen's Academy

2017 brought us the opportunity to host another Citizen's Academy, something we have not been able to do since 2014. This year's academy was attended by 11 individuals. The academy is a platform we use to give those who attend the opportunity to learn more about the duties and responsibilities of the Employees of the Sparta Police Department, and the day-to-day operations of the Sparta Police Department.

The academy included ten sessions beginning in September and ending in November. With the exception of one Saturday morning session and one Saturday afternoon session, the participants met on Tuesday nights starting at 7 pm and ending at 9 pm.

2017 Sessions included a visit to the Monroe County Dispatch Center, the Monroe County Jail, the Monroe County Court House (for a presentation by Judge Ziegler and District Attorney Kevin Croninger) the shooting range, the Emergency Vehicle Operation Course and the Sparta Municipal Airport for a presentation by Gundersen Air and a chance for participants to use rescue equipment belonging to the Sparta Area Fire District. Participants were also given a presentation on physical evidence and provided the opportunity to try their hand at gathering fingerprints. A demonstration provided by the canine handlers and their four legged partners gave the participants some insight into the capabilities of the canine unit and as always is at or near the top of the list when participants are asked what their favorite session was. Other favorites listed by the participants were the Taser presentation where participants are given the opportunity to receive a five second shock from the Taser and the shoot-don't shoot scenarios where participants are provided with an air soft gun and conduct mock traffic stops where they are presented with a scenario where deadly force may or may not be appropriate.

The academy ended with a dinner where Certificates of Completion and Sparta Police Department Challenge coins were provided to the participants. The picture below was taken during the range day. Kevin Croninger joined us at the range this year, because when he previously attended the academy he was unable to make it to the range day.






